Honorable Sir,

All India judges Association condemns the act of attempt to fire at a judge, who was discharging his duty of delivering justice at Karnal. The judges, particularly the judges working in the trial courts, are discharging their duties facing all the odds. The Judges are occasionally facing assaults with different objects. Such assaults have not dampened spirit of the judiciary to deliver justice without fear. But repeated acts of use of violence targeting the judges may have an adverse effect on the justice delivery system.

2. Want of protection to shield the judges from such violent acts is frustrating and not a good sign for the democracy. The judges who are protecting fundamental rights of "we the people of India" stay without protection and now and then face the act of

physical attack from the miscreants. This incident of an attempted use of firearm had shaken the belief of the judges in police machinery.

In order to maintain high values of democracy protectors of constitutional values should be protected from the violent attacks of frenzy litigants. **All India Judges Association** is aware that up till now the the State of Punjab must have taken action to biff up security of the judges. I convey you concern of **All India Judges Association** about the security of the judges and request you to do needful.
